Ms [REDACTED] came to the ofc w/her spouse. Upon entering the ofc the guard went through her procedure of cell phone off, weapons, etc. The guard was glancing in the top of Ms [REDACTED] purse when she heard Ms [REDACTED] say under her breath something about Anthrax. The guard asked her to repeat what she had said. Ms [REDACTED] said I am just joking about the anthrax. The guard informed her we take this very serious and wanted her ID info. Ms [REDACTED] became upset and went outside, when she realized the mistake she had made. Her husband stayed inside to finish his business. The guard at this time came to me and I immediately contacted FPS and told them what the lady had said and that she was outside. They sent local law enforcement. I went outside with the guard and waited for the PD and talked with the husband. He says his wife is prone to mouthing off when she shouldnt. The PD interviewed Mr and Mrs [REDACTED] and warned her of the seriousness of her words. Determined no threat existed
