Incident Summary

A package that was received in the mailroom was taken to the front desk by a CR who was performing reception duties. When the package was opened, a white powder came out onto the desk. The envelope was taken back to the mailroom and the desk was wiped clean. I was out of the office so the CR called the DM in Muskogee for guidance. The local PD, fire dept and FPS was contacted and all arrived onsite. The guard contacted the Denver Mega Center. The police sealed off the mailroom and ordered the office closed @ 2:00 pm and sent ee home. HazMat arrived, sent the substance to Oklahoma City for testing; & recalled employees Ryan Gassaway, T2 CR; Kurtis Jones, T2CR & daughter, Boyd Nave T16 CR;Verla Bloomfield, T16 CR; Joe Deschaine, DM; Steve Whitlock, Guard ██████████ claimant-they were sent thru decontamination shower onsite sent to hospital for observation. All were released about 8:00pm ██████████ were also in the office but were not called back. Test negative.
