

On 24 July 2008, SSA Regional Commissioner Ramona Schuenemeyer deleted the email in which the Union demanding bargaining and information **without reading it**, which means the Union is never going to get a response to its request for information.

AFGE Local 2505 is requesting information pursuant to 5 USC 7114(b)(4).

At the arbitration hearing on Wednesday, June 25 in the Tulsa, OK Library, SSA called an employee witness: Lollie Driulini.

Ms Driulini testified that she spoke about the grievance that was the subject of the arbitration with Dana Callahan (cc'ed above). She testified to the various information that she told Ms Callahan. In addition, Mr. Linden (cc'ed above) asked Ms Driulini questions from a binder from which I could see contained prepared, typed questions for Ms Driulini, which against, indicates that SSA spoke with Ms Driulini about the grievance in order to prepare her testimony.

The Union requests, pursuant to 5 USC 7114(b)(4), all notes, emails and copies of electronic files of the conversation between Dana Callahan and Lollie Driulini. In addition, the Union requests, pursuant to 5 USC 7114(b)(4), all notes, emails documents and copies of electronic files of the conversation between Brian Linden and all other SSA representatives and Lollie Driulini about Local 2505's Section 10 grievance / arbitration concerning the improper withholding of the Union dues of Peggy Hutcherson who was transferred from Houston to Bartlesville, OK in April, 2006.

The Union's particularized need for such information is to investigate a possible Unfair Labor Practice Charge against SSA for having formal discussions with a bargaining unit employee concerning a grievance without giving the exclusive representative, AFGE Local 2505, advanced notice and an opportunity to attend such formal discussions.
